popular system of medicine among the most frequently used treatments in CAM<sup>6,7</sup>.

Samuel Christian Friedrich Hahnemann introduced homeopathy in 1796 after the discovery of a new method of treatment with diluted remedies<sup>8</sup>.

Homeopathy (from the Greek homo, meaning similar, and pathos, meaning suffering) treats diseases by using the diluting form of naturally occurring substances which are applied according to the principle of "Similia similibus curentur". Homeopathic system of medicine considers the patient as a whole and not only tries to remove the disease but also restore the health of the patient. Homeopathic physician practices in two ways: clinical and classical. Clinical homeopathy is similar to conventional

medicine and not follows the basic principle of homeopathy. Classical homeopathy follows the basic principal strictly. Homeopathic medicines are prepared by passing through repeated dilution and succession even diluted beyond Avogadro's number<sup>9-11</sup>.

Homeopathic mother tinctures are in liquid form, prepared by the use of suitable concentration of alcohol-treated with raw material (which may be fresh or dried). There are different methods for preparation of homeopathic mother tinctures depending upon nature of the raw material. Homeopathic mother tinctures are obtained by the methods of maceration, digestion, infusion, decoction, and fermentation<sup>12,13</sup>.

Homeopathic mother tinctures of plant origin carry the hydro-alcoholic extracts of medicinal plants<sup>14</sup>.

The major difference between the mother tincture and simple extract is the ratio of alcohol with a medicinal substance. Homeopathic mother tinctures prepared by treating one part of a medicinal substance with nine parts of alcohol whereas simple extract comprises on one part of the medicinal substance and 4 or 5 parts of alcohol. Theta  $\Phi$  or Q symbol is used to represent the homeopathic mother tinctures  $^{15,16}$ .

Human being suffers from uncountable infectious diseases caused by the microorganism. A number of antibiotics have been synthesized in allopathic system of medicine and extensively used for the treatment of infectious diseases. By the unnecessary use of synthetic antimicrobial preparations, microbes have settled their resistant strains against these antimicrobial preparations, responsible for dropping down the therapeutic value of best synthetic antimicrobial preparations. Therefore, it is necessary to find out the naturally occurring medicinal substances and assess their antimicrobial activity<sup>17,18</sup>.

Homeopathic doctors use mother tinctures at their clinics for treatment of different types of diseases including skin diseases, chronic ulcers and in wound healing 19. Homeopathic tinctures are used as bacteriostatic. Microbes cannot be flourished in the presence of homeopathic mother tinctures. White blood cells and epithelial tissues are not abolished by the use of homeopathic mother tinctures which are the body's first defensive line against infection. Clinically it is observed that during the process of healing of the wound,

homeopathic mother tinctures exhibit the early and rapid curative action in comparison with the allopathic system of medicine<sup>20</sup>.

#### CONCLUSION

The mother tincture is made from a combination of the drug along with the drug .it is also known as the herbal extract, or alcoholic extract while potency is further proceeding form of diluted mother tincture, from which power of drug can be measured. It is concluded that homeopathic system of medicine is the best alternative system of medicine that kills the microbes and save immune system of our body.
